SUBJECT: 2025 Northeast Area President Election

In accordance with FMCA's Bylaws and Policies and Procedures, the National Directors representing the chapters in each designated area will nominate and elect by mail ballot their Area President. Each of the Area Presidents shall be elected for a two-year term. Please note the following procedures:

- Nominations are to be made on the enclosed form and received in the national office no later than March 3, 2025.
- ◆ On April 3, 2025, you will be sent a mail ballot listing all candidates for your area together with a return envelope, to be returned to Family RV Association's certified public accountant's office, postmarked no later than May 3, 2025. If you will be traveling during that time and you will not be able to receive the ballot at your address on file, please contact the Chapter Services Department at the national office, or e-mail chapters@fmca.com, to have the ballot sent to an alternate address.
- Each Chapter National Director and incumbent Area President has one vote in his or her area.
- ◆ The tabulation of the ballots will be done by Family RV Association's certified public accountant's office on May 13, 2025, and you will be notified of the election results.
